**DEREGISTRATION OF INDIRECT WHOLLY-OWNED SUBSIDIARIES IN
THE PEOPLE'S REPUBLIC OF CHINA**

ComfortDelGro Corporation Limited (the “**Company**”) wishes to announce the deregistration of the following subsidiaries:

(1) **COMFORTDELGRO RENT-A-CAR (CHENGDU) CO., LTD (“CDG RAC”)**

CDG RAC was incorporated in the People’s Republic of China in 2004. The principle business of CDG RAC was rental and leasing of vehicles. CDG RAC has been dormant since 2021. The deregistration of CDG RAC has been completed and it has ceased to be an indirect wholly-owned subsidiary of the Company.

(2) **CHONGQING COMFORTDELGRO DRIVER TRAINING CO., LTD (“CCDT”)**

CCDT was incorporated in the People’s Republic of China in 2006. The principle business of CCDT was the operation of driving schools. CCDT has been dormant since 2018. The deregistration of CCDT has been completed and it has ceased to be an indirect wholly-owned subsidiary of the Company.

(3) **CHENGDU COMFORTDELGRO SHENGDUO CONSULTING CO., LTD (“CCSC”)**

CCSC was incorporated in the People’s Republic of China. It was acquired by Chengdu ComfortDelGro Taxi Co., Ltd, an indirect wholly-owned subsidiary of the Company in 2006. The principle business of CCSC was the operation of taxi business. CCSC has been dormant since 2013. The deregistration of CCSC had been completed and it has ceased to be an indirect wholly-owned subsidiary of the Company.

The deregistration of the aforesaid companies is not expected to have any material impact on the net tangible assets or earnings per share of the Company for the financial year ending 31 December 2022.

None of the Directors or controlling shareholders of the Company has any direct or indirect interest in in the aforesaid companies, save for their respective interests, through their shareholding and/or directorships, as the case may be, in the Company.
